## STAY INFORMED ABOUT DEVELOPMENT PROPOSALS IN YOUR COMMUNITY

Notification of new applications will provide your community an opportunity to participate early in the development review process. To receive informational mailings on new development projects in your community, your organization must register with The Maryland-National Capital Park and Planning Commission. In an effort to maintain an accurate database, **all associations must re-register every two years.**

**Note:** Post office (P.O.) boxes are not allowed (except for Person to Receive Mailing and Management Company entries). ALL associations, and their officers, must have a primary address within the association's geographical area of interest.

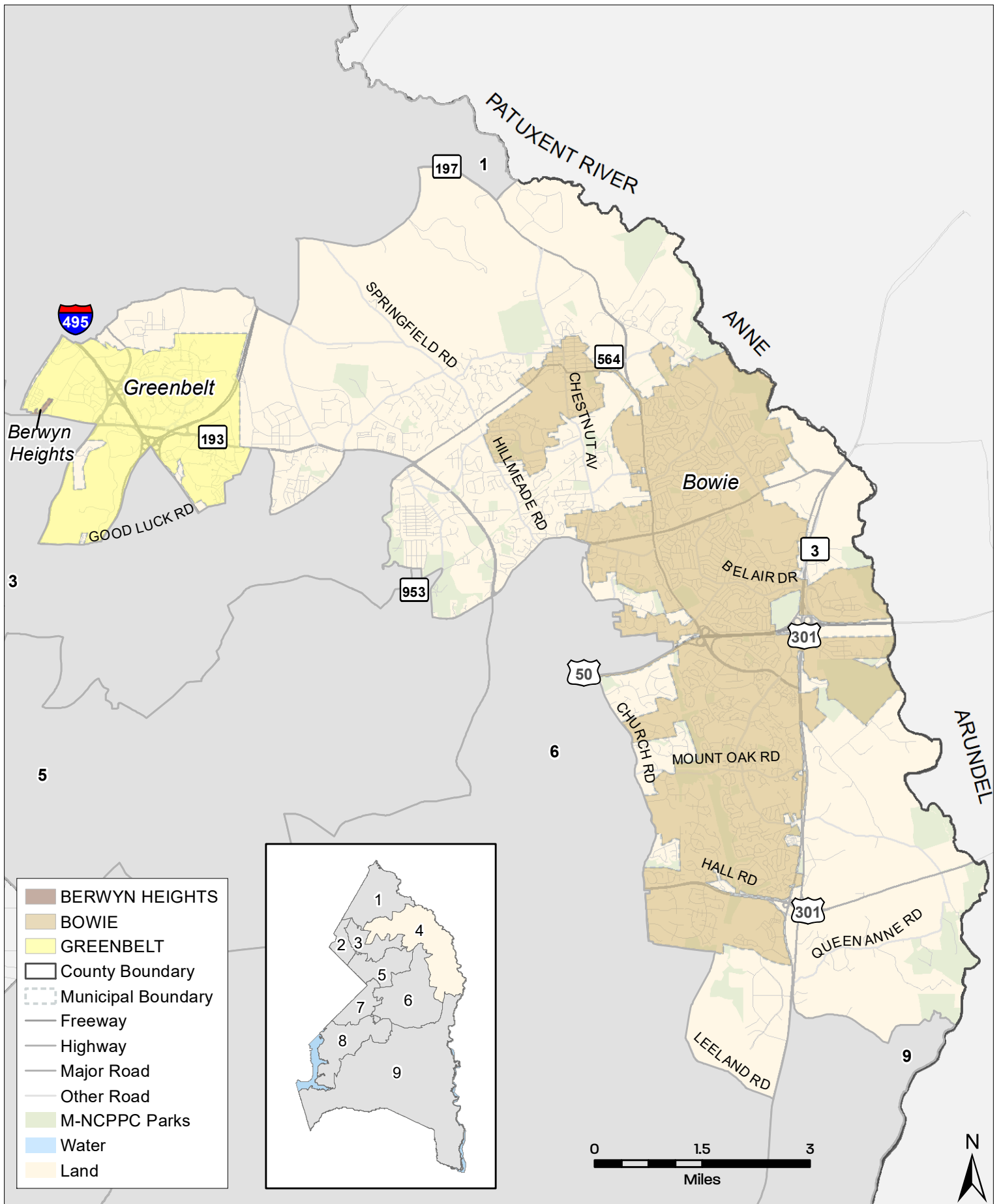


## Council District 1

### Prince George's County, MD



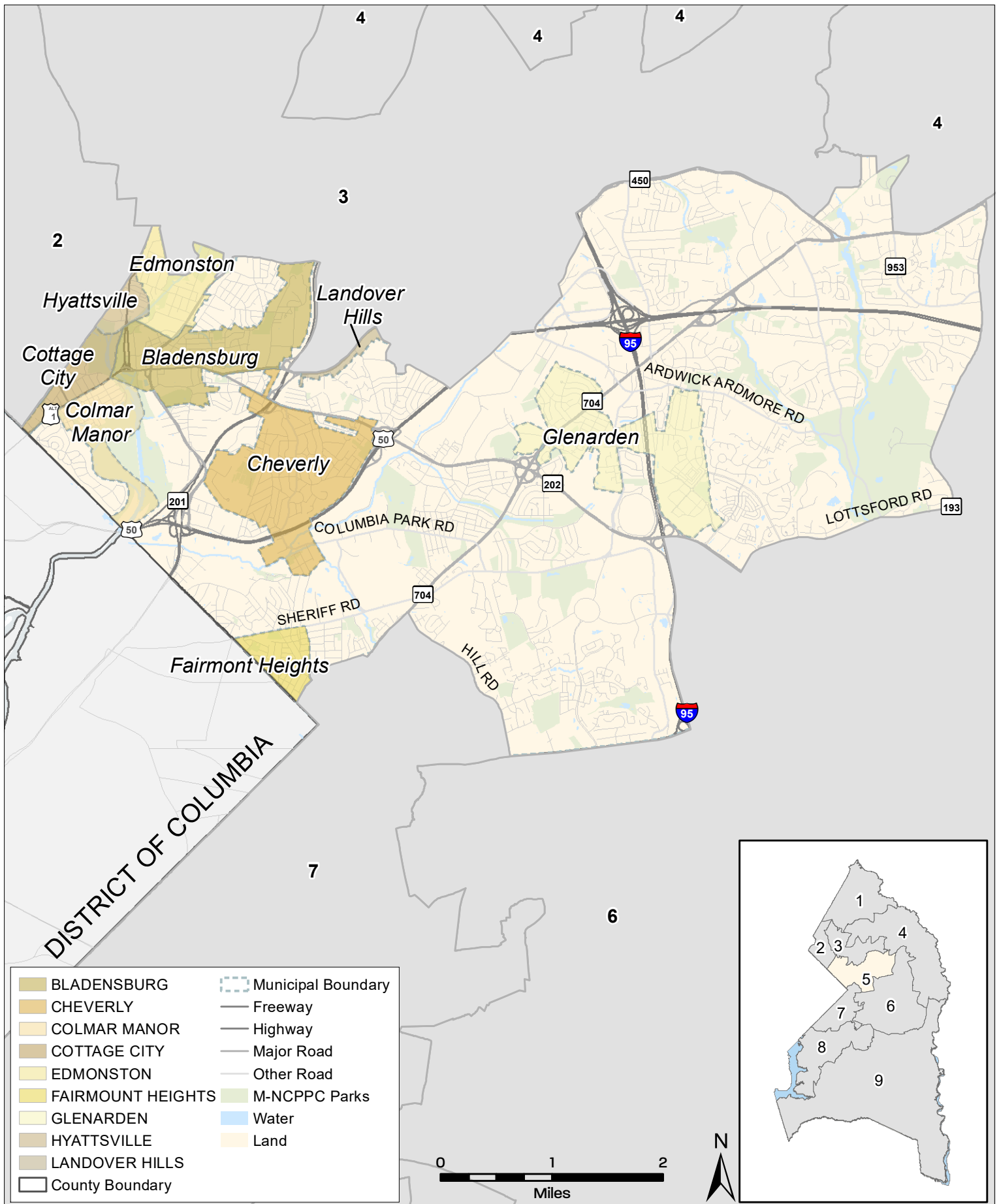

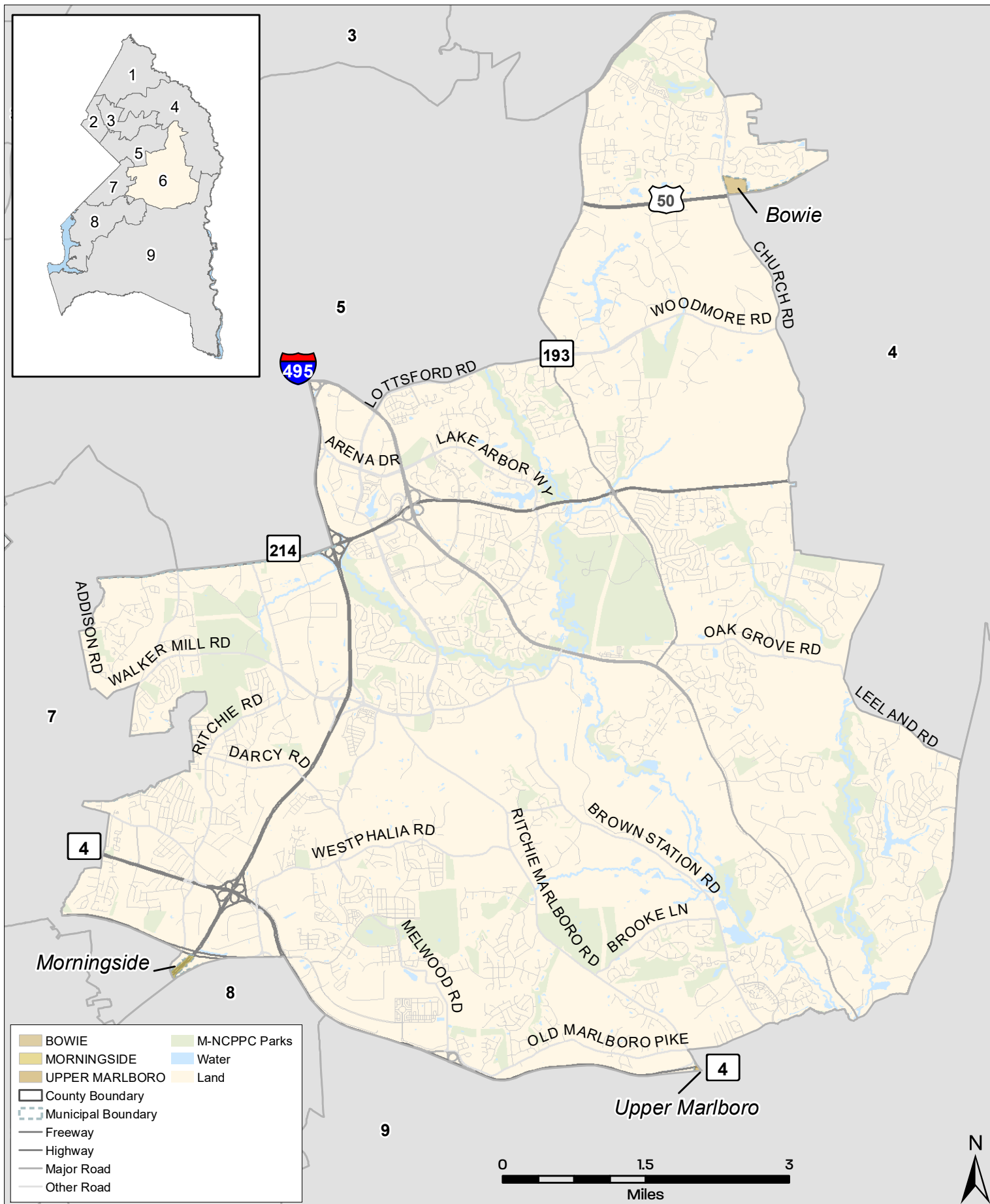

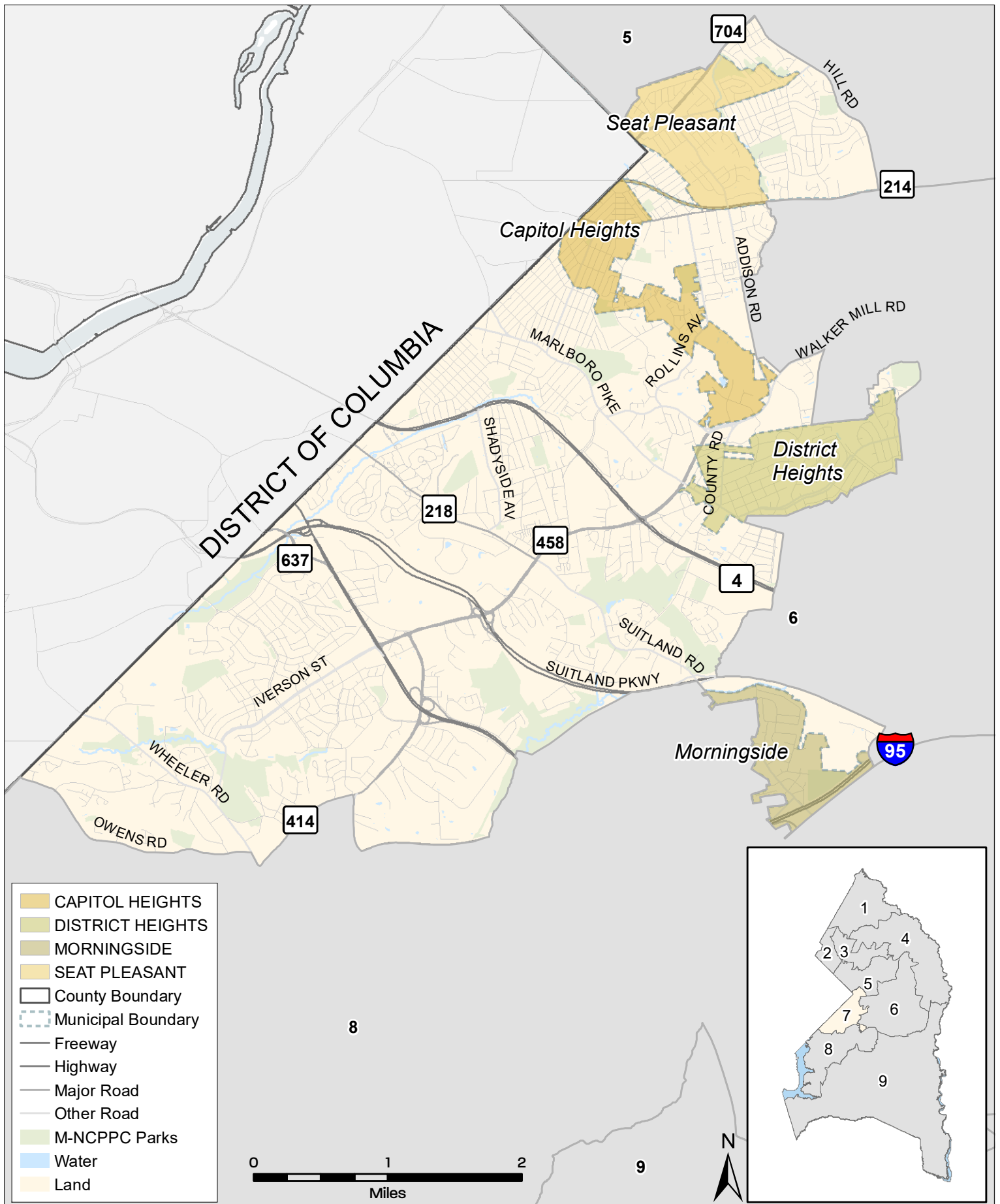

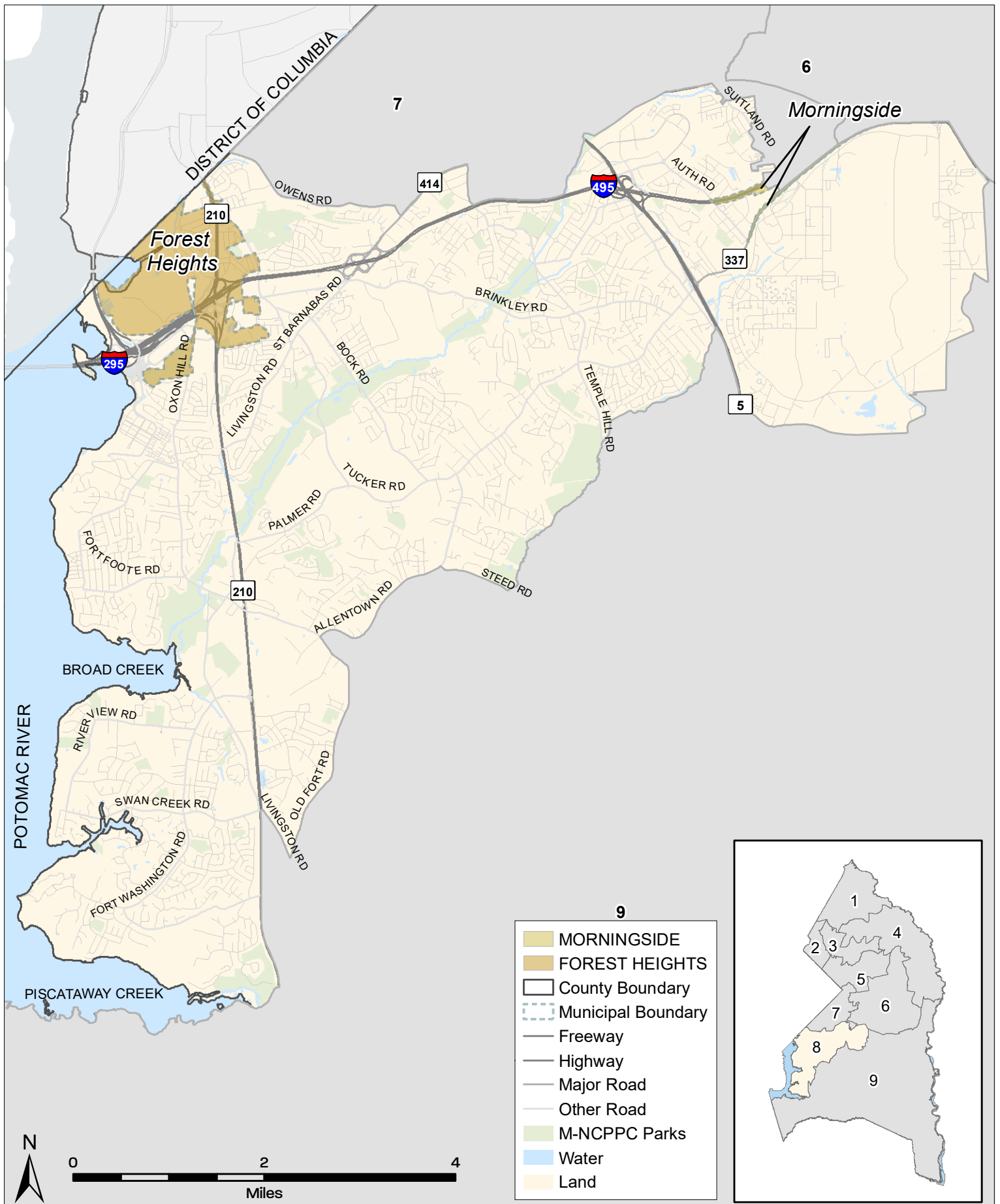

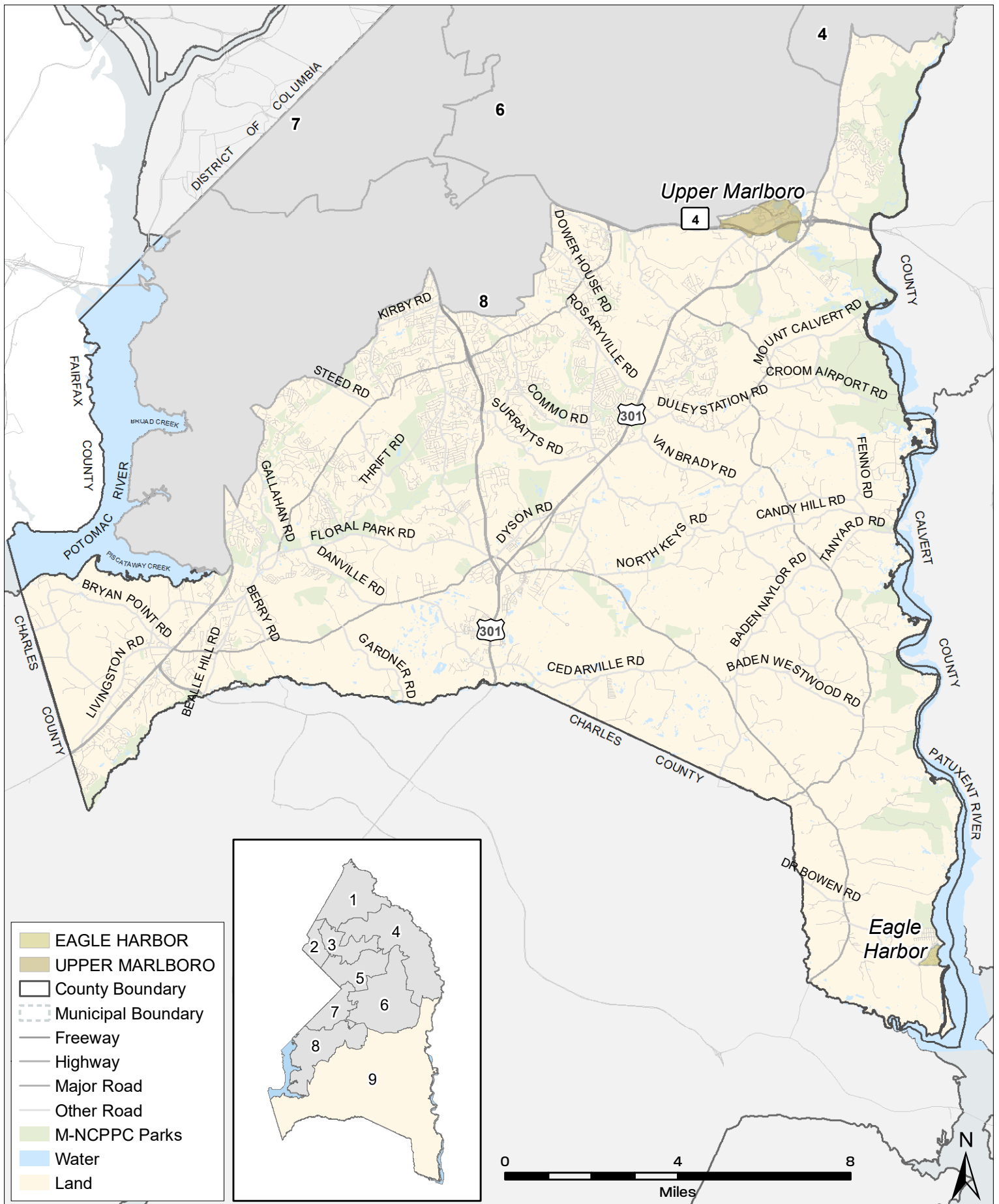
